Minors are not allowed in the licensed premises. The maximum number of seats in the licensed premise shall not exceed 25. The square footage of the licensed premises shall not exceed 25% of the total square footage of retail store, including the licensed premises. If this is a new application, or a change in the licensed premise has occurred, a copy must be submitted with application.**

Do you understand that any license granted upon this application will not be transferable except by specific authority of said governing body, and will authorize the retail sale of wine as herein applied for only at the place and on the premises designated in this application and in such license? _____.

The applicant herein does hereby consent that the (President of the Board of City Commissioners and the Police Commissioner) and any police officer of the City of Devils Lake aforesaid, or any person or persons duly authorized by the (City Council) of said City may enter upon the premises described in this application at any hour of the day or night, and that they and any one of them shall have free access to the said described premises and every part thereof for the purpose of inspecting the said premises and the records of this applicant relating to the purchase and sale of wine, and applicant does hereby waive any and all rights that he/she may have under the Constitution of the United States and the Constitution of the State of North Dakota relative to searches and seizures without issuance of a search warrant, and the applicant does hereby agree that such immunities shall never be claimed by him/her, and that such search, seizure, and inspection may be made at any time without a search warrant. Do you agree to each provision of this paragraph?

Per the Ordinance upon renewal of this license I am providing a statement certifying gross retail sales and wine sales from the previous calendar year. I understand that the gross sales of alcoholic beverages may not be greater than 30% of the total gross sales of all other items sold at retail and alcoholic beverages. The Board of City Commissioners may, in its discretion, require certification of any statement by a certified public accountant, retained by the licensee.
